







MONTHLY SUMMARY

The portfolio recorded a negative return in October as rates lifted on the increasing probability of a Trump victory in the US elections.

The key detractors for the month were Crown Castle, Ferrovial and American Tower Corporation. The US tower companies Crown Castle and American Tower fell on the back of higher US bond yields. Crown Castle was further affected as it failed to provide an update on its operational strategic review at its result (which otherwise was slightly ahead of expectations). Ferrovial fell on comments in Toronto, Canada, that Ontario's Premier Ford was open to buying back the 407 ETR motorway as a solution to congestion in the metro area.

The key contributors for the month were Aena, Dominion Energy and Xcel Energy. Spanish airport company Aena lifted on higher-than-expected scheduled winter season capacity for its Spanish airports. Dominion Energy, a diversified US utility, lifted as it announced a project with Amazon to explore advancement of Small Modular Reactor nuclear development in Virginia and as it had a constructive rate case settlement in North Carolina. US integrated power utility Xcel Energy's share price jumped as it lifted long-term EPS guidance backed by capex to meet increasing load growth demands.
