Magellan Asset Management Limited as Responsible Entity of the Magellan Global Fund ("**MGF**") advises that, since the Appendix 3C announcement of the buy-back of MGF Closed Class Units on 30 November 2020, and the Appendices 3D lodged on 19 October 2021 and 29 November 2022, 244,834,625 MGF Closed Class Units have been cancelled<sup>1</sup>.

Following the cancellations, and as at 28 April 2023, there are 1,457,584,989 MGF Closed Class Units on issue.

The primary objectives of the Fund are to achieve attractive risk-adjusted returns over the medium to long-term, while reducing the risk of permanent capital loss. It is not our intention to hedge the foreign currency exposure of the Fund arising from investments in overseas markets.
