#### About the Magellan Global Equities Fund (Currency Hedged) – Active ETF

The Fund's primary investment objective is to achieve attractive risk-adjusted returns over the medium to longterm, while reducing the risk of permanent capital loss. The Fund aims to invest in companies that have sustainable competitive advantages which translate into returns on capital in excess of their cost of capital. The Fund's portfolio will comprise 20 to 40 investments, with some exposure to cash. The capital component of the foreign currency exposure of the Fund is intended to be substantially hedged.
