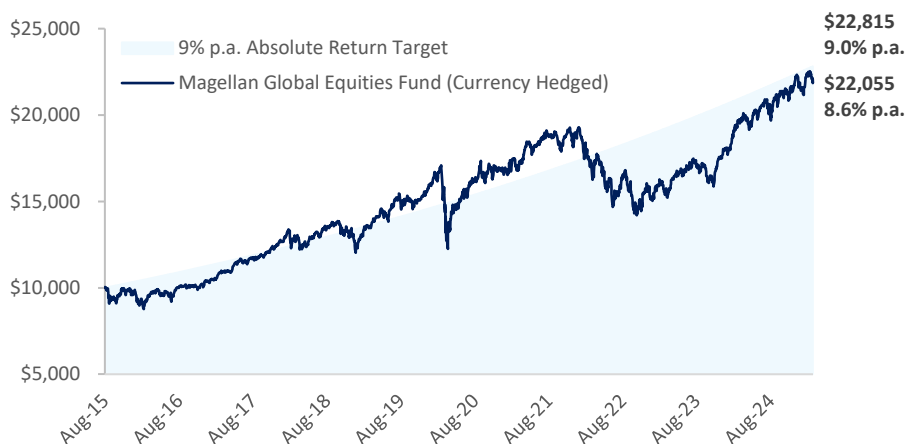

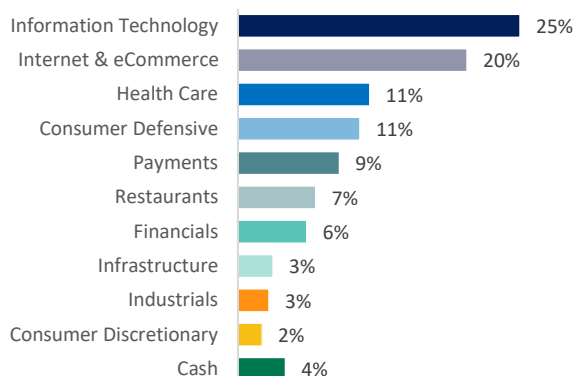

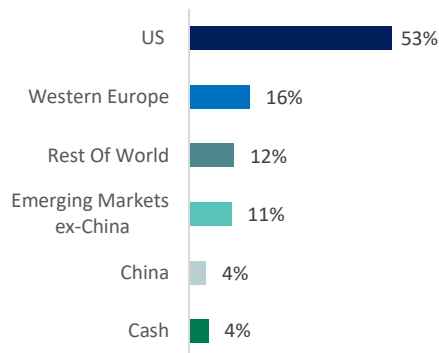
SECTOR EXPOSURE BY SOURCE OF REVENUE³

MONTHLY SUMMARY

While the outlook for global share markets has become less certain, our base case is that markets are more likely to grind higher than collapse over the next year or so. The portfolio continues to take a below-market level of risk, so we are well positioned should markets perform weaker than our base case suggests. What is more important to portfolio returns is the shape of the risk we are taking. In February we increased the defensiveness of the portfolio by slightly rotating away from growth and reduced our exposure to companies at most risk of a faster-than-expected US-China decoupling.

The major contributors to fund performance were Yum! Brands, Nestlé and Intercontinental Exchange. Yum's 4Q24 result showed stabilising sales in the Middle East and China after disruption last year and continued strong momentum in the US Taco Bell business. We continue to be attracted to Yum's global store roll-out opportunity and its highly franchised, cash-generative business model. Investors are becoming more confident in Nestlé's turnaround strategy. The company's full-year results revealed a better-than-expected medium-term profit outlook, underpinned by Nestlé's global footprint and diversified food and beverage portfolio. Intercontinental Exchange reported robust volume growth in its exchange business while lower US interest rates led investors to become more optimistic about mortgage refinancing activity, which would benefit their Mortgage Technology business.

The largest detractors were Amazon, Alphabet and Taiwan Semiconductor Manufacturing Company (TSMC). Amazon's share price fell as investors became less optimistic about AI tailwinds, sentiment towards the economic outlook weakened and investors contemplated the impact of Trump's tariffs. While Alphabet's full-year result was solid, investors were disappointed by weaker-than-expected growth in its cloud business on capacity constraints and the increased capex, despite this spending addressing these constraints. TSMC was affected by uncertainty on tariffs, the outlook for chip demand for GPUs and concerns the company would be coerced to invest in Intel.
