TO VOTE BY COMPLETING THE PROXY FORM

STEP 1 APPOINTMENT OF PROXY

Indicate who you want to appoint as your Proxy.

If you wish to appoint the Chair of the Meeting as your proxy, mark the box. If you wish to appoint someone else as your proxy please write the full name of that individual or body corporate. If you do not mark the box and leave this section blank, or your named proxy does not attend the Meeting, the Chair of the Meeting will be your proxy. A proxy need not be an Open Class Unitholder. Do not write the name of MGF or the registered Open Class Unitholder in the space.

Appointment of a Second Proxy

You are entitled to appoint up to two proxies to attend the Meeting and vote. If you wish to appoint a second proxy, an additional Proxy Form may be obtained by contacting Boardroom or you may copy this form.

To appoint a second proxy you must:

- complete two Proxy Forms. On each Proxy Form state the percentage of your voting rights or the number of Open Class Units applicable to that form. If the appointments do not specify the percentage or number of votes that each proxy may exercise, each proxy may exercise half your votes. Fractions of votes will be disregarded; and
- return both forms together in the same envelope.

STEP 2 VOTING DIRECTIONS TO YOUR PROXY

To direct your proxy how to vote, mark one of the boxes opposite the item of business. All your Open Class Units will be voted in accordance with such a direction unless you indicate only a portion of Open Class Units are to be voted on the item by inserting the percentage or number that you wish to vote in the appropriate box or boxes. If your proxy is not the Chair of the Meeting, and you do not mark any of the boxes on the item, your proxy may vote as they choose. Alternatively, if your proxy is the Chair of the Meeting and you do not mark any of the boxes on the Resolution, you expressly authorise, and direct the Chair of the Meeting to vote in favour of the Resolution. If you mark more than one box on an item for all your Open Class Units your vote on the item will be invalid.

Proxy which is a Body Corporate

Where a body corporate is appointed as your proxy, the representative of that body corporate attending the Meeting must have provided an "Appointment of Corporate Representative" form prior to admission. STEP 3 SIGN THE FORM

This Proxy Form **must** be signed as follows:

Individual: This form is to be signed by the registered Open Class Unitholder.

Joint Holding: Where the holding is in more than one name, all the Open Class Unitholders should sign.

Power of Attorney: To sign under a Power of Attorney, attach a certified photocopy of the Power of Attorney to this Proxy Form when you return it.

Companies: This Proxy Form must be signed by a Director jointly with either another Director or a Company Secretary. Where the company has a Sole Director who is also the Sole Company Secretary, this form should be signed by that person. **Please indicate the office held by signing in the appropriate place.**

STEP 4 LODGEMENT

Proxy Forms (and any Power of Attorney under which they are signed) must be received no later than 48 hours before the commencement of the Meeting, therefore by 9.30am (AEST) on 24 June 2024. Any Proxy Form received after that time will not be valid for the scheduled Meeting.
